

# **Body Temple Ignite Coaching Program Membership Agreement**

By purchasing this membership, you agree to become a member of Body Temple Health and Wellness Ignite Coaching Program and you are acknowledging that you have read, agree to and accept all of the terms and conditions contained in this agreement. The Agreement with Body Temple Health & Wellness LLC (the "Company" or "we/us") automatically becomes a binding contract between you and the Company and applies to your participation in the program.

If you chose a payment plan, your first membership payment is processed immediately, and the remaining payments will be auto-charged every 30 days until the balance is completed. No refunds will be issued at any time. The payment plans are solely offered to alleviate one large payment and **does not in any way** constitute a 'month-to-month' or subscription-type membership.

By paying the first installment or full membership, you authorize the Company to charge your credit or debit card as payment for your membership in the program. You agree that you are responsible for full payment of membership, regardless of whether you utilize the coaching sessions or participate in programs and training, and regardless of whether you have selected a lump sum or monthly payment plan.

You further agree that, (4) all materials and information provided to you by the Company are confidential and proprietary intellectual property, and belong solely and exclusively to the Company, and may only be used by you as authorized by the Company, and (5) the reproduction, distribution (including online posting/sharing) of any audios, documents or training materials by anyone except the Company is strictly prohibited (6) you may not duplicate the courses or any part of the Body Temple Ignite Library in whole or part and/or distribute the information for any reason. Further, you agree that if you violate, or display any likelihood of violating, any of your agreements contained in this paragraph, the Company and/or the other program participant(s) will be entitled to injunctive relief to prohibit any such violations to protect against the harm of such violations.

All disputes regarding this agreement shall be decided pursuant to Oregon law and in an Oregon court with venue in Clackamas County. This written contract contains the entire agreement between the parties. Any oral discussions or statements not contained in this writing are not part of this contact. Any changes to this written contract must be in writing and signed by both parties.
